- He shall lead the technology team of Bank and also other verticals of the Cooperative sector.
- He shall develop software products for Banking, consumer services, marketing activities, retail Solutions and back office operations in cooperative sector.
- He shall provide Mobile Banking / Net Banking applications, following Cyber security norms.
- He shall develop separate dashboard for DCCBs, Apex and other institutions and the Registrar of Cooperative Societies.
- He should enable migration of the Core Banking Solution from ASP model to own model for Apex Bank, District Central Cooperative Banks, Urban Cooperative Banks and other institutions.
- He shall take up any other important responsibilities as the management desires.
- He shall also handle databases, provide Data analytics to the Management.
- He will follow up the hardware deployment and usage and shall appraise IT activities and progress made to RCS periodically.

- He will facilitate identification of suitable staff from the existing manpower, train them on software and hardware handling and form IT team at State Level, District level and at each institution level.
- He will liaise and coordinate with different Apex Cooperative institutions and the RCS office for providing appropriate technology solutions to all the stakeholders.
- He shall follow any other Technology related assignments provided by the RCS or the Apex Bank.
- He shall follow up, monitor and ensure smooth functioning of existing / ongoing software and do ensure timely completion of the projects.
- To ensure that the IT solutions provided in the Apex Bank and DCCBs are in tune with the expectations of the prospective young customers and consumers.
- Advising the Cooperative Institutions on how best to use technology to improve the business in all aspects.
- He will also act as the Chief Information Security Officer (CISO) of the Bank.
- The CISO will be responsible for preparing, reviewing and enforcing the policies related to Information Systems Security.

#### Selection Procedure:

- A preliminary screening of the application will be carried out by the Bank and the candidates will be shortlisted based on qualifications and experience.
- The shortlisted candidates will be called for an interview by the Expert Committee constituted for the purpose.
- Shortlisted candidates have to make a presentation on their technical skills and exposure to Information Security.
- Verification of documents and credentials presented by the candidate will be done.
- Appointment order will be issued after satisfaction of the eligibility and experience of the candidate.
- The selected candidate has to take charge of the post within one month from the date of receiving appointment order.
- If the candidate is already working in another organisation, he has to get relieving order from the present organisation before taking charge as IT Specialist in TNSC Bank.
